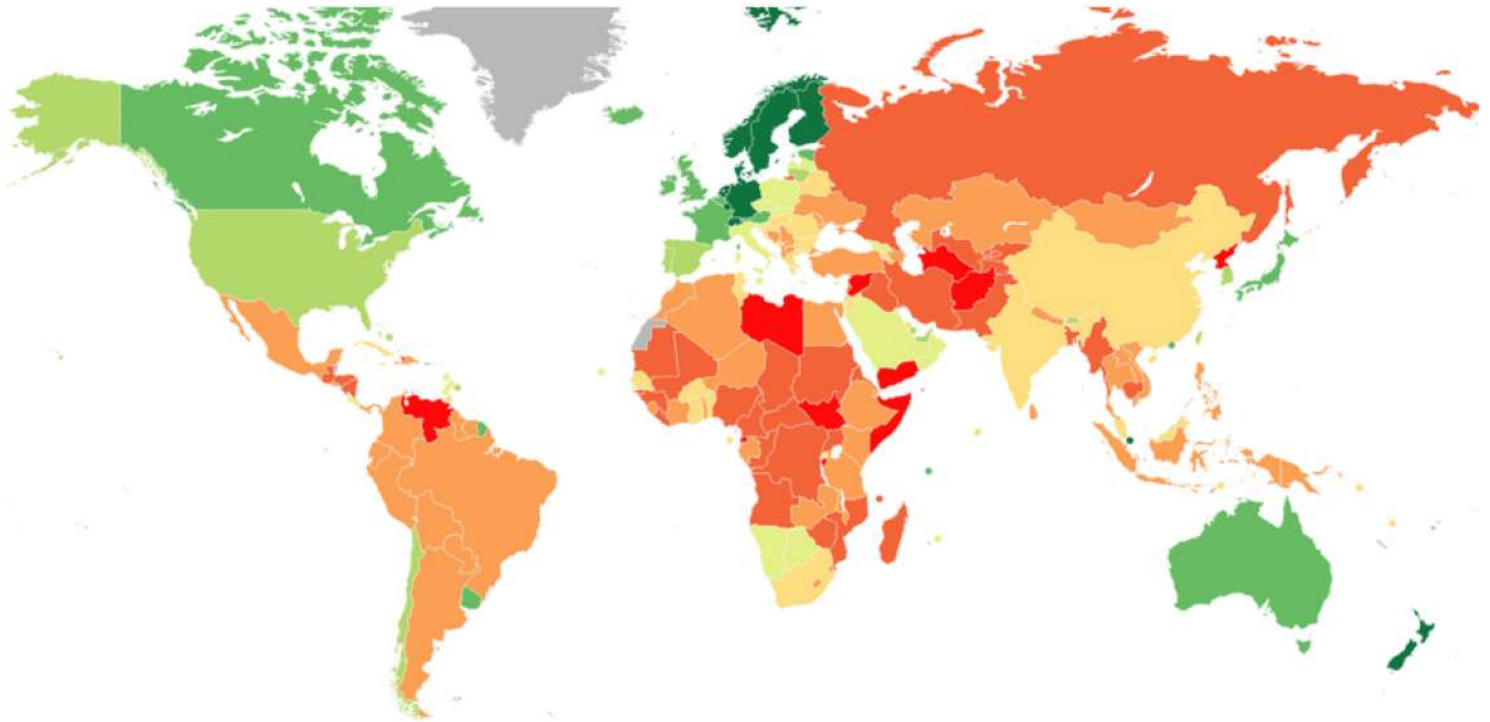


CORRUPTION RISK INDICATORS IN EMERGENCY



THE CO.R.E PROJECT

A brief overview

The CO.R.E COrruption Risk indicators in Emergency project, funded under the Internal Security Fund Police Program of the European Commission, focuses on assessing the risk of corruption in public procurement, one of the key objectives of the European agenda.

The project intends to create a replicable procedure for the construction of corruption risk indicators in an emergency period, which can be used by national anti-corruption agencies, law enforcement agencies, investigative journalism networks, media and citizens, starting from the collection and cross processing of data on public procurement.

To achieve this main goal, the project team will provide a practical guide, software codes, real data examples and a database with interactive maps in order to provide information on corruption indicators in a simple and accessible way.
